Tables & Chairs are a 24-hour rental period. They will be dropped off by our team the Day before your event unless you pay the extra 25% fee for an extra 24-hour rental.

We will return the next morning after your event _____ (DATE) to pick up the rental.

All Chairs & tables must be wiped down, stacked, folded and ready for pickup upon our arrival the day after your event by 8am for us to pick up or a 50% fee of rental for each item will be charged for our team to complete the pickup ourselves. If chairs and tables are not wiped down you will lose your \$50 deposit

*If any chairs are missing or broken beyond repair there will be a \$20 charge per chair for replacement.

* If any tables are missing or broken beyond repair there will be a \$80 charge per table for replacement

* If any ice bin tables are missing or broken beyond repair there will be a \$160 charge per table for replacement

Fuel Fee is calculated Roundtrip from Fenton 48430 per trip [full service with delivery & pickup = 2 trips] The first 5 miles of each trip are no-charge, anything over 5 miles each way = \$.50c/mile

Deliveries are limited to 1st floor exterior access only. Delivery Vehicle must be able to get within 50 feet of placement of rented items for drop-off.

Items must be stacked & folded, ready for us pickup as they were left or a 50% fee will be charged to compensate as a rush fee for our team to do it.

Customer is responsible for the above to avoid any extra charge.

Delivery is only made to the address on contract. The Lessee (customer) grants permission & right to enter said property for delivery & pickup of equipment prior to & after rental is complete.

The lessee voluntarily releases, indemnifies and agrees to hold harmless and discharge The Chair Dressers from any & all liability, claims, demands actions or rights of actions, whether personal to itself or a third party which are related to, arise out of or are in any way connected to the rental on this agreement. The lessee agrees to reimburse any reasonable attorney's fees and costs that may be incurred by The Chair Dressers in the defense of any such liability claim, demand, action or cause of action.

Lessee acknowledges and represents they have adequate homeowners' insurance, or other liability insurance to cover any bodily injury or property damage which might occur to itself, it's guests or its invitees from the use of rented equipment or else lessee agrees to bear the costs of defense & liability of injury or damage itself.

Lessee agrees to supervise both the equipment and it's use at all-time said equipment is in the possession of the lessee. Lessee agrees to common use and safety of rented equipment.

Lessee agrees to not stand on chairs or tables which will put added stress to equipment and cause them to malfunction for improper use.

Lessee acknowledges that the maximum weight limit of chairs is 634lbs and will monitor use among their guests.

The lessee acknowledges & certifies that they had sufficient opportunity to read this entire contract, and understands the content and that it was executed freely, and without duress of any kind and agrees to be bound to the terms & conditions.

\$50 Refundable Retainer is due with Signed Contract immediately to reserve your date.

Remaining Balance Due 1 month before event.

The \$50 retainer serves to hold your date & as a cleaning deposit & will be held until after pickup of rented equipment to assure prompt pickup of clean chairs | tables after event.

Chairs must be stacked, fully wiped down & ready for pickup by 10 am __/__/2026

\$50 Deposit will be digitally returned within up to 24hrs after pickup.

This serves to also hold your date in case you cancel, if you decide to cancel your event, the \$50 payment is non-refundable.

No other money will be due if event is cancelled.
